8 Planning & Enforcement

New Planning applications

23/0220 - Reduce the crowns of two Yew trees (T1 and T2) by 3m in height and 2m off lateral limbs, situated in a conservation area

Saltwood Village Hall, Rectory Lane, CT21 4PZ

There were no objections to this application

23/0159 – proposed replacement dwelling (involving the demolition of the existing fire damaged property) plus two additional dwellings to the rear of the site and associated external works

High Meadow, Sandling Road, CT21 4QJ

The Parish Council recommends that this application is refused for the following reasons:

The application rolls, in our view unreasonably, two elements (which ought to be separate) into one.

One element is the application for rebuilding of the family home destroyed by fire in November 2020. The Parish Council has no objection to that part of the application.

However, the Parish Council does object to the second part of the application – that two new houses should be built in the garden of High Meadow.

The plot of land to be used for building these two houses, which is within the AONB boundary, is much higher than that of the neighbouring bungalows to the south. There is already substantial disquiet among neighbouring residents should the two new two storey dwellings be granted planning permission since these proposed new builds would overlook the neighbouring properties and severely decrease the amenity and privacy currently enjoyed by those residents.

As already stated, the plot of land is within the AONB boundary. The Kent AONB Planning and Management Plan policy SD1 states that the need to conserve and enhance the natural beauty of the Kent Downs AONB is the prime purpose of the designation and is to have the highest level of protection in Development Control decisions. Policy SD3 states that new development or changes to land use will be opposed if they run counter to or disregard the primary purpose of Kent AONB. The Parish Council considers the addition of the new houses to the site fails to conserve or enhance the natural beauty.

KCC Highways has also expressed concern regarding the use of the vehicle entrance and exit for the new builds (Darke lane). For the safety of vehicles, cyclists and pedestrians (St. Augustine's primary school and Brockhill Park college students use and cross this bridle path twice daily) KCC Highways require the minimum dimensions regarded as necessary distances for visibility splays as 2.4m and 43m. This application does not demonstrate how this can be achieved. The widening of the entrance to 4.8m is also necessary – however to achieve the widening of one of Saltwood's ancient bridle paths would require the correct permissions. If the reason for such a change would be to allow the construction of new buildings within an AONB that would not be following the 'conserve and enhance' condition

23/0036 -display and erection of a non-illuminated business signage. Two signs to be arranged in triangular formation
