1 Apologies for absence

2 Registering declarations of interest in items on the Agenda

3 Minutes of the last Meeting

The Minutes of the Meeting held on 4th December 2023 were unanimously approved

4 Matters arising

The Parish Council expressed its gratitude to the Piper family for supplying the electricity for the lights for the Christmas tree on the village green.

It was agreed that a smaller Christmas tree be purchased in future years as it would be easier to decorate and dispose of.

5 KCC & FHDC Cllr reports

KCC Cllr Love spoke about Integrated Care Strategy - KCC in partnership with the NHS focusing on Public Health services to improve health outcomes. The budget overspend primarily due to the increasing cost of adult social care and special needs provision, was discussed. Cllr Love also reported that a £2m grant had been received for increasing smoking cessation uptake, and reported that he was looking at parking issues and concerns raised by residents in Highfield Close

FHDC Cllr Martin spoke about the 2024/2025 budget which would be presented to the full Council in February and he was pleased to report it should be a balanced budget. However, significant savings had to be made to achieve this, including a number of voluntary redundancies. Jim also updated on dealings with Southern Water regarding the recent sewerage discharges

c/ Banking arrangements

Cllr Boland updated on the current account offered by Metro Bank, which had no bank charges as long as £6000 was retained in the account. He noted that each Cllr (up to a maximum of three designated as signatories) could register with the bank individually - it wasn't necessary for all Cllrs to attend the bank at the same time to do this.

It was unanimously agreed to open a Metro Bank current and savings account and once fully up and running to close the current HSBC accounts. It would subsequently be necessary for the Parish Council to amend its Financial Regulations to ensure transparency and appropriate safeguards in view of the new arrangements for payments to be made by bank transfer rather than, as now, by cheque.
