#### **120. REPORTS:**

District Councillor's Report – Cllr. D. Owen raised the following matters in his report – **New initiative responding to Homelessness in Shepway** - Homelessness was an increasing problem throughout the country and Hythe did have its problems with homelessness. SDC, Dover DC and Thanet DC had received funding of £400,000 from DCLG and were working in partnership with Porchlight the Homelessness Charity to address the issues relating to homelessness. Matt Falconer from Porchlight operated in Shepway from the Civic Centre or Rainbow Centre. Porchlight considered best to deal with the homeless as Council Officers are seen an officialdom whereas Charity workers are not. Despite this Hythe's problems had not gone away just moved. **Social Housing** – Six new one-bed flats being built at Romany Way off Horn Street and affordable homes in Military Road, Cheriton. SDC were investigating acquisition of the ex. Gas Works at Ship Street, Folkestone for mixture of 85 market and affordable homes.

**Crack-down on Fly tipping** – person fined £300.00 for fly tipping of garden waste in a country caught on CCTV. Also, a Builder was seen tipping 1 ton of rubble in Crete Rod West was fined 150 hours of unpaid work, costs of £630.00 plus victim surcharge of £85.00.

During discussion Councillor expressed concerns that Phase 1 for the scheme did not include schooling, healthcare or access to amenities. Lack of these facilities until later phases of the scheme would increase traffic flow due to new residents having to access Hythe for schooling, healthcare and shopping. Cllr. Mrs. L. Spice agreed to draft a reply to Shepway District Council which would be circulated to Councillors for approval before submitting to Shepway DC.

#### **126. CHILDREN'S PLAY PARK:**

Cllr. Mrs. Spice said that the damage to the Basketball/football equipment had been reported to Safeplay Playgrounds Ltd. who had sent a quotation for the repairs. Cllr.
