Otterpool Park Garden Town –The government had invited local authorities to identify areas for new garden settlements to increase the overall number of homes being built nationally. It was the District Council's intention to bid for a garden town in the areas surrounding Otterpool Manor Farm. A broad area had been identified and a set of draft principles drawn up and if approved by Cabinet on the 08 June 2016 would form part of an expression of interest to be submitted to the government.
