## 2. DECLARATIONS OF INTEREST:

Cllr. D. Kenyon-Vaughan, Cllr. N. Matthews, Cllr. N. Matthews and Cllr. J. Stevens declared a personal interest in planning application Y16/1360/SH as they were known to the applicant.

# 3. MINUTES OF THE MEETING OF THE PARISH COUNCIL HELD ON 12 DECEMBER 2016:

# 4. MATTERS ARISING FROM THE MINUTES THE MEETING OF THE PARISH COUNCIL HELD ON THE 12 DECEMBER 2016:

Village Green – Christmas Tree. The Clerk explained that three strings of lights were arranged on the tree, each string having its own battery. Due to vandalism, the cable to one string of lights had been cut. This had added to the problems already being experienced with lighting this year's tree. It was agreed that future lighting of the Christmas tree be an agenda item for the next meeting.

#### 5. REPORTS:

**District Councillor's Report** – Cllr A. Ewart-James in his report drew attention to Council and Private Houses to be built as follows –

Philbeach, Blackhouse Hill, Hythe planning consent granted for 85 extra care units.

Council housing to be provided at Military Road, Sandgate – 35 units, Roman Way, Folkestone 8 units and Brook Lane, Sellindge 15 units.

On a 11- acre site at Bigginswood, Folkestone – 77 Private homes, 660 sq.metres of office space and 5142 sq.metres industrial area were proposed.

**Y16/1401/SH** – Hogs Green Cottage, Sandling Road, Sandling Road, Saltwood. Erection of a two- storey side and front extension and formation of a drive. No objection subject to Planning and Building Regulations. This property was in an area for low density housing.

## 9. GRANGE ROAD PLAY PARK:

**Repairs to equipment** -Cllr. Mrs. L. Spice reported, that as there had been no mention of a loose Tram track pole in the latest equipment inspection report and when she had inspected and tested the equipment had found no fault, she had cancelled the proposed works to be carried out by Playdale Playgrounds Ltd. With regard to repairs to the scramble net ground anchor, Playdale had agreed to carry out the repairs at no cost to the Parish Council.

- (b) Donation of seat Following a proposal by Cllr. N. Matthews and seconded by Cllr. Miss L. Sadler it was agreed to accept the offer from Mrs. J. Mather to erect a tree round the smaller Horse chestnut tree on The Green in memory of her husband.

## 11. OTHER CORRESPONDNCE:

**KCC Highways** – Notice of road close order on part of A26l Hythe. The A26l Hythe Road to be be closed in the vicinity of Ashford Lodge, which is between Newingreen and Pedlinge. Access to the remainder of the A26l to continue from either direction up to where the road is closed, but there will be no through access. Closures planned for the weekends of Friday 20 January, and Friday 27 January and Friday 3 February from Friday evenings at 20.00 hours through until the following Mondays at 06.00 hours. It was possible that a further closure may also be needed during the week of the February Half Term. The closure is to allow for extensive drainage improvement works to be carried out.
