# 126. MINUTES OF THE PARISH COUNCIL MEETING HELD ON THE 07 OCTOBER 2019:

# 127. MATTERS ARISING FROM PARISH COUNCIL MEETING HELD ON THE 07 October 2019:

- (a) Telephone Box The Chairman reported that he had been in contact with BT and understood that the Telephone Box was to remain but the door would not be reinstated. The Telephone Box had been cleaned.
- (b) Litter Bin Cllr. Stevens reported that he had nothing further to report on the refurbishment of the litter bins in Saltwood. A reply was awaited from Cllr. J. Peall, District Council Cabinet Member for Enforcement, Regulatory Services, Waste & Building Control.

#### **128. REPORTS:**

(a) County Councillor's Report – Cllr. R. Love reported that Cllr. Roger Gough had been elected

the new Leader of Kent County Council. He also spoke about the 2017 'good' Ofsted judgement

of Kent's Children's Services which had put Kent 's children services among the top 30% in the

country. Since 2015 the percentage of schools with good or outstanding Ofsted inspections has improved. Kent schools with an Ofsted judgement of good or better now standing at 91%. An increase from 79.6% in 2015 and is above the national average. In conclusion Cllr. Love spoke about the Local Partnership Groups established across Kent to look after the health and wellbeing of children and young people, including the Folkestone Partnership Group.

#### (b) District Councillor's Report:

The Chairman read out following report from Cllr. Mrs. L. Whybrow.

"Since my last report a number of cross-party working groups have been set up at the District Council. We are pleased to have a representative on each group - The Otterpool Working Group, The Climate & Ecological Working Group, The Folkestone Town Centre Group and The Corporate Plan Working Group.

A Low Carbon and Sustainability Specialist has been appointed to support the Climate & Ecological working group and the recommendations from the first meeting of that group include: To recommend to Council that electric vehicles, charging points, costs and location are considered when replacing fleet vehicles.

To recommend to Council that the Civic Centre building energy impact on climate change is explored and costed

To promote reduction of food waste, packaging and healthy diets to all residents using a communication channel plan, such as 'Your District Today'.

District Councillor's report contd.

At the September council meeting I proposed a recommendation that cabinet make a Fair Tax declaration. This was passed and so will now be considered by cabinet.

It was also agreed that a cross party working group be set up to look at the possibility of changing from the cabinet system to a committee system and work is now being done on this. The council has commissioned some market research in the future of Folkestone Town Centre and surveys will be carried out there during November.

Following the problems at East Kent Housing the council is carrying out a consultation regarding the possibility of bringing the management of its council housing stock back into house.
